Subject: Annuity Training and Carrier Appointment Reminder

Prior to soliciting annuity business please be sure that annuity product training has been completed.

If an application on an annuity is taken prior to completion of the training, we will reject the application and ask that you have the application and all supplemental paperwork re-signed and dated after training has been completed. **No exceptions will be granted.** 

For your convenience our product training may be taken on RegEd.

You may register online with RegEd at <u>https://secure.reged.com/industrytraining.</u> Once registered, please use the product codes below.

Product codes must be typed in exactly as shown in this bulletin to access the training so it will be best to copy and paste the code from this bulletin into RegEd.

The following RegEd product codes are for SBLI USA product training for New York products only:

- Select Choice Product Code: Select Choice\_NY
- Safe Solution Product Code: Safe Solution\_NY

\*\*As a reminder – For New York sales, Regulation 187 and AML training must also be up to date prior to soliciting business. The Reg. 187 training is also available on RegEd under Course Name - "Best Interest of Clients in Life Insurance or Annuity Transactions: NY Reg 187-1 Hour Course (485\_NY)." If your financial institution has reached an agreement with us to provide the AML training, your AML training will be automatically updated; otherwise, you will need to take our AML training, available on the portal.

The following RegEd product codes are for S.USA (non-NY) product training.

- Select Choice Product Code: Select Choice\_nonNY
- Safe Solution Product Code: Safe Solution\_nonNY

\*\*As a reminder – For non-NY sales, NAIC 4-hr or similar suitability training as required by your state and AML training must be up to date prior to soliciting business. If you took required suitability training

through Reg Ed, we will obtain this information through Reg Ed. Otherwise, proof of the suitability training should be provided with your appointment paperwork. If your financial institution has reached an agreement with us to provide the AML training, your AML training will be automatically updated; otherwise, you will need to take our AML training, available on the portal.

Pre-appointment states require a producer to have an approved and effective state appointment with the insurance carrier <u>PRIOR</u> to signing or dating a new business application in that state. If you are writing business in one of these states, please make sure your appointment is active prior to soliciting business.

We currently require pre-appointment in the following states:

- Alabama (AL)
- Florida (FL)
- Georgia (GA)
- Pennsylvania (PA)
